MEMBERSHIP AGREEMENT

Welcome to the Bideawee Dog Park. In order to use the Dog Park facilities, Bideawee, Inc. requires that prospective members of this private member-only facility agree to the terms of this document and the Liability Waiver, provide us with certain information and adhere strictly with the attached Rules and Regulations as a condition of membership (Rules and regulations may change as determined by management. Current rules and regulations are posted at the Dog Park).

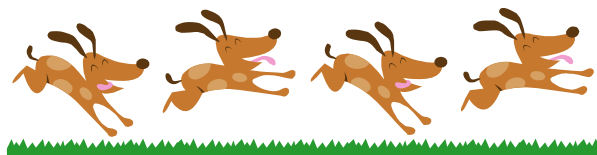
1. **Duration of Membership.** Annual membership is effective from the period the application is accepted until December 31st (annual memberships purchased in 2009 will be effective until 12/31/2010). Seasonal memberships are effective from May 1st 2010 – September 30th 2010. Renewal applications and invoices will be sent out in November of each calendar year. Annual fees may differ from year to year. If you fail to adhere to the Rules and Regulations and your membership is revoked, you will not receive any refund. If you fail to renew and pay the renewal fees, your membership will terminate on December 31st of the current year. Upon revocation or termination of membership, you and your dog will no longer be able to use the Dog Park. Please note that the Dog Park is on private property with access and use limited to active members; others will be considered trespassers and be excluded.
2. **Times of Use.** All use is subject to the Rules and Regulations but hours of use will differ with the time of year. Hours of operation will be posted and members must refrain from any use outside posted hours. We reserve the right to close the Dog Park maintenance and/or due to extreme weather conditions which prevents the safe and proper use of the park.



BIDEAWEE DOG PARK RULES AND REGULATIONS

We want you and your pet to enjoy time together. In an effort to keep you and your pooch safe and the grounds maintained you must be willing to abide by the following terms of usage.

- 🐾 Have Paw Pass visible at all times.
- 🐾 Please clean up after your dog and dispose of waste in the proper receptacle.
- 🐾 Fill in any holes dug by your dog.
- 🐾 Do not leave your dog unattended.
- 🐾 Only two dogs per person allowed at one time
- 🐾 Keep children under your watchful eye. Children under the age of 10 are not allowed in the park.
- 🐾 Children under the age of 18 must be accompanied by a parent/guardian/adult.
- 🐾 Aggressive dogs will be asked to leave the property and may be subject to membership revocation.
- 🐾 All dogs over 6 months must be spayed or neutered.
- 🐾 All dogs must be up to date on vaccinations (as determined by the State of New York) and proof of rabies may be requested if your dog is involved in a bite altercation.
- 🐾 Dogs must be on a leash at all times outside of dog park.
- 🐾 Owners or handlers are responsible for their dog's actions. Owners are legally responsible for their dogs and any injury caused by their dogs.
- 🐾 Owner is responsible for costs incurred if their dog gets sick or injured at Dog Park
- 🐾 No smoking.
- 🐾 No people food.
- 🐾 Excessive Barking is not allowed.
- 🐾 Please alert the Pet Memorial Park staff if there are any problems with the grounds or facilities.
- 🐾 **BEWARE OF TICKS AND CHIGGERS**
- 🐾 **DO NOT BRING YOUR ANIMAL INTO THE DOG PARK IF HE/SHE IS ILL.**
- 🐾 Have fun and enjoy the time spent together!

Waiver and Release**

I wish to be a member of the Bideawee Westhampton Dog Park (the "Park"). In connection with such membership ("Park Membership"), I hereby assume all risks associated with my Park Membership and do hereby release BAW from any and all claims, actions, damages and costs BAW may have or incur related to or arising out of my Park Membership (including but not limited to, injury to me and/or my pet(s) and/or injury caused by my pet(s) to another member's pet(s) or contraction of a communicable disease). I acknowledge and understand that the Park facilities will include a dog agility course and I assume any and all risks (of injury or otherwise), including without limitation, to my dog(s) and to me. If this waiver and release is not enforced, I do hereby agree that BAW's maximum liability in regard to any such claims and actions for damages and costs, including damage, injury or death to persons, animals or property, shall be limited to \$100. I further acknowledge and understand that my Park Membership is subject at all times to the good behavior of my pet(s) and BAW may revoke such membership if BAW determines, in its sole discretion, that my pet(s) is not behaving in accordance with the Park rules and code of conduct.

I agree to indemnify, defend and hold BAW (and its directors, officers, employees and other representatives) harmless from and against any claim, loss, liability, damage and/or other expense arising out of or resulting from the conduct of my pet(s) at the Park (including without limitation, injury inflicted by my pet(s) on another member and/or another member's pet(s)). In connection with my Park Membership, I hereby grant to BAW, and to other persons as BAW may designate from time to time, the absolute right and permission to videotape, film, photograph and/or record my appearance in connection with my Park Membership (my "Appearance"), and to use my name, image, persona, photograph, picture, voice, statements, biographical information, or other likeness, in whole or in part, or distorted in character or form, throughout the world, in perpetuity for any legal purpose whatsoever, including advertising, promoting and marketing BAW as a nonprofit animal welfare organization and its products and services, in web films and videos, and in television, print and other materials (collectively, the "Promotional Materials"), for use in the following media: (i) all television media; (ii) all forms of print media; (iii) any other format (including, without limitation, on BAW's website and on any third party websites and video-sharing websites (e.g., MySpace.com, YouTube.com)); (iv) distribution/downloading to mobile and handheld devices; (v) digital media; and (vi) and any and all promotional usage related to BAW and/or the Park.

I hereby waive any rights to inspect and approve the finished materials or their use. Nothing herein will constitute any obligation on BAW's to use the Promotional Materials. I agree that all right, title and interest in and to the finished product, including the copyrights therein, shall vest exclusively in BAW. I agree further that I will not hold BAW or anyone who receives permission from BAW, responsible for any claim or liability resulting from the use of my Appearance in accordance with the terms hereof, including, but not limited to, claims in the nature of copyright infringement, defamation, disparagement, slander, false light invasion of privacy or publicity or the like.

I represent and warrant that I have the full right and power to execute this Release and that the use of my Appearance, as described herein, will not violate any law or infringe upon the rights of any third party.
